## Schedule to Terms & Conditions of entry

<b>Eligible entrants</b>	This Competition is open to light truck and heavy vehicle owners, drivers and service technicians.  <b>(‘Eligible Entrant’)</b> who: (a) are operating within Australia and are aged 18 years or older; (b) have not been discovered to have breached these Terms and Conditions.
<b>Ineligible entrants</b>	Employees and immediate families of Ryco Group Pty. Ltd. and their associated agencies, and companies associated with the promotion are ineligible to enter. ## Terms & Conditions of entry

1. Information on how to enter and prize details form part of these terms & conditions (**Terms of entry**). The Terms must be read in conjunction with the Schedule. The Schedule defines the terminology used in these Terms of entry. Where there is any inconsistency between these Terms and the Schedule, the Schedule prevails. Participation in this Promotion is deemed acceptance of these Terms of entry.
2. Entry is open only to legal residents of the Eligible States/Territories who satisfy the Method of entry.
